OLUSTEE BATTLEFIELD 2013

Sadly, I received a report from Brother Linscott that a long time Educational Exhibitor James "Randy" Kerlin had passed away from a stroke on January 23rd. I have been attending the Olustee Battlefield event, representing the Dept. of Florida SUVCW, for five years. In the mornings Randy and I would have coffee together before the event would start, and in the evening a few beers after it would end. Randy was an easy guy to get along with and we would share many stories about the Civil War. The Dept. placed a memorial plaque on our display table in honor of his memory. He was well known in the Civil War community and he will be missed. The Olustee tag this year was black, which I thought appropriate.



Friday Feb. 15th I spent educating children about the Union regiments that fought at the Battle of Olustee and they would get a chance to pick up a Springfield 1861 musket. There was always a look

of surprise on their faces as they realized how heavy the musket is. The emphasis was on the history of African American Union regiments that served in the Battle of Olustee. I would finish the talk by telling how important it is to learn their family history. Towards the end of the day Brother Lloyd Monroe and his wife stopped by to say hello before he went to meet with District 10 State Representative, Elizabeth W. Porter, regarding the Olustee Monument Project. After the meeting with the State Rep. Dept. Commander Ward stopped by and we discussed Dept. business at dinner.



Saturday Feb. 16th I invited Brother Brad Quinlan of the Dept. of Georgia and South Carolina to join with the Dept. of Florida. While I recruited new members, Brother Brad would sell & sign the books he wrote. One book is titled "Duty Well Performed" (\$30) the book covers the exploits of the 21st Ohio. The regiment included the ancestor of United States V.P. Mr. Dick Cheney. His ancestor was Capt. Samuel F. Cheney. Brother Brad had done the research on the Vice President's ancestor and told many colorful and interesting stories about his interaction with the Vice President. DEPARTMENT RESOLUTION

The following resolution and proposal is brought before the members in the Department of Florida at their 17th Annual Encampment June 16th, 2012 and is ACCEPTED ~~DECLINED~~.

BE IT KNOWN that the 10th Army Corp holds the distinction of being the only Union Army Corp to fight in the State of Florida during the war of the rebellion 1861 to 1865.

BE IT NOW RESOLVED that the Department of Florida adopt the Union Army 10th Corp symbol as a badge or insignia of the Department of Florida, Sons of Union Veterans of the Civil War.

WHEREAS the Department of Florida is authorized under the bylaws Article XVI, Section 1; to adopt a Department badge or insignia, which shall be governed and does not conflict with the C&R criteria for recognition devices as defined under the C&R Chapter V, Article III, Section 3, Sub-Sections M, and P.

THEREFORE the Department of Florida shall adopt recognition devices, its insignia in the form of the 10th Army Corp symbol used by the 10th Army Corp of the late War of the Rebellion 1861 to 1865, to be worn by the members in the Department of Florida, Sons of Union Veterans of the Civil War. That this symbol when worn will distinguish their members from members of other Departments within the Fraternal Order of Sons of Union Veterans of the Civil War at all public events.

UPON adoption of the Union Army 10th Corp symbol for recognition devices the Department Commander shall form an annual committee to copyright the symbol and maintain such. To investigate what manufacturers may fabricate possible recognition devices as specified in the C&R Chapter V, Article III, Section 3, Sub-Sections M, & P. And to establish pricing on the Department of Florida recognition devices based on quotes from qualified manufacturers.

HISTORY OF THE 10TH CORPS ARMY BADGE: ITS SIGNIFICANCE TO THE CIVIL WAR IN FLORIDA

On the eve of the Rebellion the Regular Army of the United States was essentially a frontier constabulary whose 16,000 officers and men were organized into 198 companies scattered across the nation at seventy-nine different posts. In 1861, the U.S. Army was under the command of Lieutenant General Winfield Scott, the seventy-five-year-old hero of the Mexican-American War. His position as general-in-chief was traditional, not statutory, because secretaries-of-war since 1821 had designated a general to be in charge of the field forces without formal Congressional approval. The field forces themselves were controlled through a series of geographic departments whose commanders reported directly to the general-in-chief. The U.S. Federal government had two basic options for the use of the Regular Army. It could be divided into training and leadership cadre for newly formed volunteer regiments or be retained in units to provide a reliable nucleus for the U.S. Federal Army in coming battles to preserve the Union of the old slave republic. Lt. General Scott wanted the Regulars to fight as units and therefore the war, was fought primarily with State-militia volunteer officers and men, the vast majority of who had no previous military training or experience. The Federals began the war with a Regular Army organized into an essentially Napoleonic, musket-equipped structure. Each of the ten prewar infantry regiments consisted of ten 87-man companies with a maximum authorized strength of 878. At the beginning of the Rebellion, the Federals added nine Regular infantry regiments with a newer "French Model" organizational structure. The new regiments contained three battalions, with a maximum authorized strength of 2,452. The new Regular battalion, with eight 100-man companies, was, in effect, equivalent to the prewar regiment. The U.S. Federal War Department established a volunteer infantry regimental organization with a strength that could range from 866 to 1,046 (varying in authorized strength by up to 180 infantry privates). These smaller units were formed into Divisions, Corps and Departments of the Union Army. Various enlistment figures exist, but the best estimates are that approximately two million men enlisted in the Union Army during 1861-65. Of that number, 1 million were under arms when the Rebellion ended.

Early in the war, an Expeditionary Force was created to support the blockade strategy of the Lincoln administration. It was a combined military operation between the Navy and the Army. The Army would provide ground troops under the command of Brigadier General Thomas West Sherman and the Naval Force was under the command of Commodore Samuel F. Dupont. The Expeditionary Force formed in September of 1861, it was at this time that the military career of what would become the 10th Army Corp began. The first engagement November 4th 1861 was at Port Royal, S.C. And on January 1st, 1862 the regiments of what would eventually be part of the 10th Army Corp were again engaged in support of an action to take the fort at Port Royal Ferry, S.C., under the direction of General Isaac Stevens 2nd Brigade Exped'y Corp. After many months preparing for the siege of Fort Pulaski, Georgia, General Thomas W. Sherman was relieved of Command of the Expeditionary Corp in March of 1862.

The Department of the South was created under the Command of Major General David Hunter from the troops of the Expeditionary Corp. It was on this date, April 10, 1862, that the troops from the Expeditionary Army Corp participated in the siege of Fort Pulaski, Georgia under the Command of Brigadier General Gilmore. Military history was made during the siege of Fort Pulaski. For the first time in military history rifled canon successfully reduced a Fortress from over a mile away. What was thought to take months of siege only took 30 hours. The Confederate Commander of Fort Pulaski was told by no less a man than General Lee himself that the canon placed, a mile away on Tybee Island, Ga., would not be a problem. The various regiments of the Army Corp had been stationed throughout the Sea Islands along the shores of South Carolina, Georgia and Florida. These same Union troops occupied the cities of Jacksonville and St. Augustine Florida. On April 13, 1862, following the Union capture of Ft. Pulaski Maj. Gen. David Hunter issued General Order No. 7 freeing those enslaved. The General also advocated enlistment of black soldiers in the Union Army. President Lincoln overturned the order.

This was the first indication that the war was not about preserving the old slave republic but about establishing a new republic providing freedom to all peoples. In January 1863 Pres. Lincoln would issue the Emancipation Proclamation. The Bureau of Colored Troops was established on May 22, 1863.

During this time tens of thousands of slaves escaped from their plantation masters to the occupation forces of the Union Army located along these shores. It was at this time that the Army established housing, food, medical care and education to the escaped slaves. This organization laid the foundation of what would be known later as the Freedman's Bureau. The Expeditionary Corp also has the distinction of mustering the first colored regiments that were formed from the freed slaves.

Organized under General Orders No. 123 September 9th, 1862 the Tenth Union Army Corp was established from troops in the Department of the South. Major General David Hunter was relieved of command on September 16th, 1862. The newly formed Tenth Army Corp was placed under the command of Major General O. M. Mitchel.

At the time these troops were stationed principally at Hilton Head, S.C., and Beaufort, S.C., the order including also the troops at Fort Pulaski, Ga., Key West, Fla., Fernandina, Fla., and St. Augustine, Fla.; in all, 14,602, present and absent, with 10,190 present for duty. There were 14 regiments of infantry, 1 of engineers, a battalion of cavalry, and the usual compliment of light batteries. The object of the new commander was the capture of Charleston. The first action was the destruction of the Charleston-Savannah railroad. While the battle at Coosawhatchie towards that purpose was successful, Major General O. M. Mitchel was taken down with yellow fever and died on October 30th, 1862. In January 1863 Major General Hunter assumed command of the Tenth Corp. In June 1863 General Quincy Gilmore took command of the 10th Corp, the forces under General Gillmore participated in the various operations about Charleston Harbor. The principal event was the bloody assault on Fort Wagner, July 18, 1863. This assault was made by a column of three brigades,--Strong's, Putnam's, and Stevenson's, the whole under command of General Truman H. Seymour. General Strong's brigade led the assault, with the 54th Massachusetts (Colored) at the head of his column. The attack was a failure, resulting in a loss of 246 killed, 880 wounded, and 389 missing; total, 1,515. The most of the missing were killed or wounded, but few of them ever returning. To this loss should be added 339 casualties, which occurred in an attack on Fort Wagner, July 11th, a week before, an attempt made by three regiments only. Two of the three brigade commanders, General Strong and Colonel Putnam, were killed in the assault of the 18th, Putnam falling after he had effected an entrance into the fort. Stevenson's Brigade was held mainly in reserve. In February, 1864, Seymour's Division, of about 7,000 men, sailed for Florida, where it was engaged on the 20th in the battle of Olustee, a defeat in which some of the regiments suffered terribly. In April, 1864, the Tenth Corps was ordered to Virginia, where it was placed in General Butler's Army of the James, which was composed of the Tenth and Eighteenth Corps. The Tenth assembled at Yorktown, Va., where it was organized into the three divisions of Terry, Turner, and Ames, numbering, as present for duty, 16,812 infantry, and 1,114 artillerymen, with 46 guns. Afterwards the Tenth Corp was transferred to the Army of the James.

The Army of the James landed at Bermuda Hundred, May 6, 1864, and a month of active service and hard fighting immediately commenced, the Tenth Corps losing in its operations around Drewry's Bluff, 374 killed, 2,475 wounded, and 807 missing; total, 3,656. Butler's operations resulting in nothing but failures, General Grant ordered the greater part of his forces to the support of the Army of the Potomac. Accordingly, on the 29th of May, General W. F. Smith, commanding the Eighteenth Corps, took the First (Brooks') and Second (Martindale's) Divisions of his own corps, and the Second (Devens') and Third (Ames') Divisions of the Tenth Corps, and proceeded to Cold Harbor, where these divisions cooperated with the Army of the Potomac in the terrible fighting which commenced immediately upon their arrival. While at Cold Harbor, these two divisions of the Tenth Corps were known as part of the Eighteenth Corps, forming the Third Division, under command of General Devens.

Upon the close of the fighting at Cold Harbor, the two divisions returned by water transports to Bermuda Hundred, but consolidated as the Second Division, Tenth A. C.

On the 14th of August, the Tenth Corps, under command of General David B. Birney, crossed the James and became engaged with the enemy at Deep Bottom, General Terry's division taking a prominent part in this action. The casualties in the corps were: 213 killed, 1,154 wounded, 311 missing; total, 1,678. On September 29th, Birney crossed again with his corps, and fought at Chaffin's Farm, his command consisting of Terry's and Ames' divisions, together with a brigade of colored troops, under General William Birney. Loss: 74 killed, 587 wounded, 302 missing; total, 963. In the unsuccessful attack on Fort Gilmer, and at Newmarket heights, these colored troops displayed great gallantry. General David B. Birney died at Philadelphia, October 18, 1864, and was succeeded by General Terry, who was in command of the corps during the fighting on the Darbytown Road, and at the battle of Fair Oaks, October 27, 1864.

On December 3, 1864, the corps was discontinued, and its regiments were assigned to the newly formed Twenty-fourth Corps, which was composed of the white troops from the Tenth and Eighteenth Corps. But immediately after this transfer, Ames' Division, together with Abbott's Brigade of this new corps, were detached and ordered on the Fort Fisher expedition. After the brilliant capture of Fort Fisher by these troops, they remained in North Carolina, and, in March, 1865, the Tenth Corps was revived. As reorganized, it consisted of Birge's (1st) Division, composed of three brigades taken from Grover's Division of the Nineteenth Corps, then stationed at Savannah; of Ames' (2nd) Division, composed of the troops which fought at Fort Fisher; of Paine's (3d) Division, colored troops; and of Abbott's Separate Brigade, numbering in all 12,099 men. General Terry, who was in command at the victory of Fort Fisher, was placed at the head of the corps. But the war was then near its close, and in August, 1865, the organization was discontinued.

Summary:

1. The Department of Florida remains viable, with worthy progress and achievements in some areas, and challenges in others
2. National Treasurer Orr received the Department of Florida report due March 2013
3. IRS November filing deadlines were met; May deadlines are being met
4. Department Encampment is Saturday June 15, 2013 in St. Cloud. C-in-C Mellor is scheduled to attend
5. A new Camp is being organized in the Jacksonville area
6. A Sesquicentennial Signature Event is being planned for October 2013 in the Tampa area
7. A Sesquicentennial Signature Event has been approved by the National Sesquicentennial Committee for February 2014 at Olustee
 - A. President Monroe (Monument Commission, DoFL) and Department Commander Ward met with Representative Porter (Florida House) advancing the creation of a first Olustee monument recognizing Union Veterans at Olustee
8. The March annual Battle at Narcoossee Mill is an event multiple Department of Florida Camps participate in
9. The December Department Mid-year Conference (Officers Call) in St. Cloud was well attended and effective
10. The Concord Cemetery restoration project was completed with the installation of a remembrance bench
11. There is a Department website
12. The "Dispatch" is the Department newsletter
13. Since June 2012, I attended meetings at all Camps at least once, and participated in Camp activities, including the reenactment at Webster
14. I participated in C-in-C Mellor's testimonial dinner in Massachusetts
15. Implementation of the 10th Army Corps insignia as a Department insignia is advancing
16. I completed the 2012 Department Graves Registration Officer course and examination
17. Opposition to the Fort Concord Project surfaced in municipal divisions. This delayed the original schedule, and likely will down-size the concept
18. Wooden nickels distributed at NE'12 were delivered to Camps
19. I was commissioned to serve as 7MD Adjutant, SVR, and continue as Amzi D. Harmon Company Commander.

20. The one Daughters of Union Veterans of the Civil War tent (Tent 10) in Florida achieved sufficient growth to create a second tent (Tent 11). The Department attends meetings and activities of both.
21. Regarding relations with fraternal orders:
 - A. MOLLUS- I received a request to establish contact with Zellwood Museum. In addition, establishing (re-establishing) a Florida Commandery is progressing.
 - B. The Department participated in an annual March Sons of the American Revolution event observing the last naval battle of the American Revolution off Cape Canaveral
 - C. An American Legion rifle squad provided honor volleys at the Private King gravestone dedication ceremony at Punta Gorda November 10, 2012.
22. Regarding history in general, Ponce de Leon arrived and named Florida 500 years ago April 2. "Viva Florida" is a yearlong observance.

Recommendations: none, because I know recommendations are required to be resolved.

I encourage the transition to IRS 501(c)(3) recognition going forward and retroactively.

I also encourage life membership (1) fee being 20 times annual dues, (2) amount separately invested to return an annual amount equal to annual dues, (3) distributions to Departments and through them to Camps of an amount equal to Department and Camp annual dues, (4) suspension of acceptance of new life memberships until 1 through 3 are promulgated.

Department Order #5 Series 2012-2013 13 February 2013

1. The Battle of Olustee had a substantial impact on the Union Servicemen involved. The Department of Florida therefore has invested a presence at the Olustee re-enactment for several years
2. I appoint Brother Farrell as 2013 Olustee Quartermaster
 - A. I invite Lucius L. Mitchell Camp 4 Commander Custer to temporarily transfer custody of the Camp 4 tent, tarp, and related implements to Quartermaster Farrell.
 - B. I authorize temporary transfer of the Department and American flags, flagpoles, eagle, and sheaths to Quartermaster Farrell February 12, 2013. Brother Farrell reports he holds personal flag stakes, display tables, displays, and appropriate overnight camping items.
3. Department Council Member Farrell reports he intends to depart Palm Bay 4:00 am Thursday February 14, 2013. He intends to arrive by noon, and be set up by evening. Friday 8:00 am school field trip groups are expected as part of education day, perhaps winding down by 3:00 pm. Saturday and Sunday are re-enactment and public access days. DJVC Slavin also plans to arrive Thursday evening and participate with the Liberty Guards Mess portraying the 48th New York. The LGM marches 1:00 pm and 5:00 PM Friday. Brother Mike is Olustee Coordinator. Otherwise, when I am not present, DJVC Slavin represents the Department. When neither of us are present, Department Council Farrell, PDC represents the Department. In all of our absence, DS Monroe represents the Department.
4. A meeting with State Representative Elizabeth Porter 4:00 pm Friday February 15, 2013 at her 678 Southeast Baya Drive, Lake City, Florida 32025-6038 office (386-719-4600) is planned. Department of Florida Monument Commission President Monroe, Council Member Farrell, PDC, JVC Slavin, and I are authorized delegates. This means our Olustee campsite may be unattended for a time Friday. Aside from that meeting, Brother Monroe and I intend to be at Olustee Friday.
5. Navigation: north on I-95 to Jacksonville, then west on I-10, then southwest on SR-90. For the turnpike, exit to SR-90 east to Lake City, then further east to Olustee. Either way, look for an Olustee Battlefield sign.

6. Fees: we anticipate fees will be waived for SUVCW participants. Please be courteous if a waiver is not granted.
7. Shelter: Camp onsite. Hotels are at Lake City (45 minutes west), or Jacksonville (45 minutes east).
