Department Order #1 Series 2012-2013 16 June 2012 (revised 7/1/12)

- 1. You elected me to the office of Commander, and together we will strive to achieve our mission with Fraternity, Charity, and Loyalty.
- 2. On behalf of all of us, I thank Camp 7 for hosting an excellent 2012 Department Encampment in Pembroke Pines.
- 3. We meet separately from the Allied Orders, and this is a good opportunity to remember that we share a common mission with our Sisters. I welcome communications with the Women's Relief Corps, Auxiliary to the Grand Army of the Republic (WRC), Daughters of Union Veterans of the Civil War 1861-1865 (DUVCW: both Tent 10 and the newly formed Tent 11), Ladies of the Grand Army of the Republic (LGAR), and the Auxiliary to the Sons of Union Veterans of the Civil War (ASUVCW).
- 4. My focus this year will be for the Department to be recognized by government, academia and the general public in Florida as the leading source of information pertaining to history (including genealogy) and preservation initiatives associated with the Soldiers, Sailors and Marines who fought to preserve the Union, to paraphrase our SUVCW Commander in Chief. The recent restoration and rededication of Concord Cemetery is already leading to a follow-on, larger project that will advance this focus in Casselberry, and recent activities in all Camps are doing the same. The Department Encampment address by Barbara Gannon, author of "The Won Cause" and University of Central Florida faculty member also advanced our mission.
- 5. The Civil War sesquicentennial continues, building on observances at Fort Pickens and New Smyrna (Beach). The Tampa area will be the 2013 site, and Olustee the 2014 site. The Sesquicentennial Special Committee is extended for these. The Monument Commission is independent and continues in force, with Brother Monroe continuing as President. I encourage all Brothers to support both.

If you keep your Department Secretary and Department Commander informed, we can help all Brothers be informed of your Camp's good works.
- 18. Again, thank you for giving me the opportunity to serve the Department of Florida. I hope to see each Brother at a Camp meeting, at operations the Camp conducts or participates in, and at the June 15, 2013 Department Encampment.
